## **OFF-SITE IMPROVEMENTS**

- Pulte to install an 8-foot wide asphalt pedestrian/bicycle path from the entrance of the development on Silverbell Road running northerly through the development to be constructed during the first phase of residential development.
- Provide at no cost to the Township an 8-foot wide easement for future extension of the internal pedestrian/bicycle path to the Bald Mountain Recreational Area.
- Provide at no cost to the Township an 8-foot wide easement across the frontage of the property along Kern Road for the future pathway along Kern Road.
- Install at its own expense and 8-foot wide asphalt pathway on the north side of Silverbell from Kaeleaf Road across the frontage of the development to be constructed during the first phase of residential development.
- Install at its own expense an 8-foot wide asphalt and/or wooded boardwalk pathway on the south side of Silverbell from Squirrel Road to Kern Road during the first phase of development.
- Enhanced improvements to Jesse Decker Park to include the construction of two little league baseball fields, with fencing, backstops, benches and a gravel parking lot.
- At the Township's request, no paving of Kern Road unless mandated by RCOC in order to preserve landmark trees and rural character.
- If the Township is unable to obtain necessary easements from property owners along Silverbell Road, in lieu of the path being constructed, \$223,000 shall be contributed to the Township for construction of the Silverbell pathway in the future.
- Payment of \$150,000 to the Township to be used to install a double right turn lane from Silverbell Road at the intersection with Lapeer Road (M-24) in connection with the proposed Lapeer Road improvement project scheduled to begin 2016.
- Contribute \$400,000 to the Township if Kern Road is not required to be paved by RCOC. Township may use the \$400,000 in its discretion for future road improvements.

Please discuss with the Safety Path Advisory Committee this request to extend the Joslyn Road safety path from Hammerslea to Brown Road. (Would it be helpful to conduct a petition drive?)

There is no safe place for walkers and bikers to travel on this busy, high speed road. Just this morning I passed two people on bikes and on any given day there are people walking along the side of the road. As a note of interest, Dan Dewey uses this portion of Joslyn on a regular basis as it is near his home.

A possible route would be to cross Joslyn at Silverbelle and install a path on the east side of Joslyn from Silverbelle to Brown Road.
