Development Updates

Menard's – The board (ribbon) cutting was held on Monday, August 13th.

<u>Hyattt House</u> – They will be building a new proto-type with 110 rooms near Baldwin

<u>Aldi's</u> - They will be building a store in front of Menard's in the grassy area between the two driveways.

<u>Meetings with Other Developers</u> – A \$15,000,000 multi-use development is planned for the area east of Menard's.

Discussions have been held with Ed Adler and Bob Roth for their property on the west side of Baldwin north of Morgan Road.

Construction on Baldwin road has stopped because of the lockout by the construction companies against the Operating Engineers Union.

Dan's Excavating was the successful bidder for Baldwin Road Phase II, but there will a different paving company.

It was moved by Donnie Steele and supported by Tony Montgomery to go to Closed Session to discuss an Attorney's opinion at 5:28pm. Motion carried by roll call vote 7-0.

It was moved by JoAnn Van Tassel and supported by Tony Mongomery to go to Open Session at 6:00pm Motion carried.

Sale of 313 Brown Road – No action was taken

<u>Pocket Parks Update</u> – Chris Barnett reported that the Township has reached agreement with the Road Commission for Oakland County to purchase the southeast corner of Baldwin and Jordan for \$90,000.00 and the southwest corner of Baldwin and Gregory at no cost. He indicated that he would be looking for grants to develop these Pocket Parks. JoAnn Van Tassel stressed the need to include the Gingell family history in the Gregory location.. Chris Barnett said it would be included in the final plan and that there will be a monetary contribution from the developers of Gregory Meadows.

<u>Marketing Update</u> – Gary Roberts said there needs to be a \$338,000,000 increase in taxable value over the base value to make this project work. Liberty Way Realty has assembled a number of parcels on Georgia and Huston and are interested in creating a little neighborhood area.
