V. HOMEOWNER AFFIDAVIT		
I hereby certify the electrical work described on this permit application shall be installed by myself in my own home in which I am living or about to occupy. All work shall be installed in accordance with the State Electrical Code and shall not be enclosed, covered up, or put into operation until it has been inspected and approved by the Township Electrical Inspector.		
VI. GENERAL INFORMATION		
GENERAL: Electrical work shall not be started until the Electrical Permit has been issued by the Orion Township Building Department. All installations shall be in conformance with the State Electrical Code. No work shall be concealed until it has been inspected.		
INSPECTIONS: All inspections will be scheduled online at accessmygov.com . Inspections scheduled before 7:00 p.m. will be scheduled for the following business day unless otherwise noted. Electrical Inspections are typically Monday - Friday between 2:00 a.m. and 5:00 p.m.		
PERMIT RENEWAL: All permits shall be valid for 180 days. However, an additional 180 day renewal may be obtained by the original permit holder in writing by payment of a \$60.00 renewal fee.		
PLAN REVIEW FEES: Plan review (in house) \$100.00. When review of construction documents is performed by outside consultants, the fee shall be charged at 1.2 times the actual cost plus shipping.		
RE-INSPECTIONS: If any scheduled inspection is not ready when the inspector arrives on site or the inspector is unable to enter the site, a re-inspection fee of \$60.00 will be charged.		
CANCELATIONS / REFUNDS: See fee schedule
