Ordinance No. 133

Uniform Traffic Code

Adopted February 18, 2003

AN ORDINANCE TO ADOPT BY REFERENCE THE OCTOBER 2002 EDITION OF THE UNIFORM TRAFFIC CODE FOR CITIES, TOWNSHIPS, AND VILLAGES (UTC) FOR THE PURPOSE OF REGULATING TRAFFIC AND MOTOR VEHICLES IN THE CHARTER TOWNSHIP OF ORION AND TO RESCIND ORDINANCE NO. 89 WHICH ADOPTED THE PREVIOUS VERSION OF THE UTC.

Section 1 - Purpose and Intent

This Ordinance is adopted for the purpose and intent to adopt by reference the October 2002 edition of the Uniform Traffic Code for Cities, Townships, and Villages (UTC) promulgated by the director of the Michigan Department of State Police pursuant to the Administrative Procedures Act of 1969, 1969 PA 306, MCL 24.201 to 24.328 and made effective October 30, 2002, and all future amendments and revisions to the Uniform Traffic Code when they are promulgated and effective in this state, for the regulation of traffic and motor vehicles in the Charter Township of Orion. The further purpose and intent of this Ordinance is to rescind Ordinance No. 89 which adopted by reference the previous version of the UTC.

Section 2 - Adoption of Uniform Traffic Code for Cities, Townships, and Villages, Amendments and Revisions

The Uniform Traffic Code for Cities, Townships, and Villages as promulgated by the Director of the Michigan Department of State Police pursuant to the Administrative Procedures Act of 1969, 1969 PA 306, MCL 24.201 to 24.328 and made effective October 30, 2002, and all future amendments and revisions of the Uniform Traffic Code when they are promulgated and effective in this state are incorporated by reference.

Section 3 - References in the Uniform Traffic Code

References in the Uniform Traffic Code for Cities, Townships, and Villages shall mean the Township of Orion.

Section 4 - Copies

Printed complete copies of the October 2002 edition of the Uniform Traffic Code for Cities, Townships, and Villages shall be kept on file in the office of the Township Clerk and made available to the public at all times the office is open.

Section 5 - Penalties

The penalties provided in the Uniform Traffic Code for Cities, Townships, and Villages are adopted by reference.

Section 6 - Severability and Savings

If any provision of this Ordinance is held invalid, the invalidity does not affect other provisions that can be given effect without the invalid provision. All proceedings pending and all rights and liabilities existing, acquired or incurred at the time this Ordinance takes effect are saved and may be consummated according to the law when they were commenced.

Section 7 - Effective Date

This Ordinance shall be published in a newspaper of general circulation in the Charter Township of Orion, qualified under State law to publish legal notices, and shall become effective upon publication, as provided by law.
